The notation '[NP]' in a rule means that a kiteboard may not protest another kiteboard for breaking that rule. This changes RRS 60.1(a).

### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 [DP] RRS 40.1 applies and is amended so that it applies at all times while afloat.
- 1.3 The following national prescription may require advance preparation:  
*RRS 46 – Person in Charge – Sail Canada prescribes that the designated person in charge, if resident in Canada, shall be a member of Sail Canada through either a club affiliated to Sail Canada or such person's Provincial Sailing Association.*
- 1.4 RRS Appendix T "Arbitration" will apply.

- 1.6 [DP] Protocols related to COVID-19 may be published at any time, state when they will take effect, and will state if they have the status of a rule.

## 2 SAILING INSTRUCTIONS

2.1 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions (SSI) that will be on the online official notice board.

3.2 [DP] While racing, except in an emergency, a kiteboard shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all kiteboards.

## 4 ELIGIBILITY AND ENTRY

4.1 The regatta is open to all open foiling kiteboards and IKA Formula Kites.

4.2 Eligible kiteboards may enter by completing the online form and submitting it through the event website. [www.cork.org](http://www.cork.org)

4.3 A kiteboard that sails with a **sail bib** number that **they are** not registered with or received permission from the race committee to **sail compete** will receive a 10% scoring penalty.

4.4 To complete the entry process, participants must complete the attached checklist (Appendix 3)

5.1 The entry fee covers racing, site use at Elevator Bay Pier from September 23 – 25, 2022, and a regatta souvenir.

5.2 Support personnel are required to be registered online. Coaches are required to be registered online with fee paid prior to the event to be eligible to coach. Coaches fees cover site use from September 23-25 and regatta souvenir.

5.3 In the case of event cancellation or postponement by CORK, all fees except for bank charges will be refunded.

5.4 All fees except for bank charges will be refunded to kiteboards that cancel prior to September 16 2022.

6.1 Kiteboards may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.

- 7.1 The race committee may run one extra race on a day provided that they do not get more than one race ahead of the daily schedule and do not exceed the number of races scheduled for the event.

## 8 VENUE

- 8.1 Sailing will be in Lake Ontario South of Elevator Bay Pier.

## 9 COURSES

- 9.1 The courses to be sailed will be a windward/leeward configuration suitable for Kites.

## 10 SCORING

- 10.1 One race is required to constitute a series.
- 10.2 When fewer than five races have been completed, a kiteboard's series score will be the total of her race scores.
- 10.3 When from five to nine races have been completed, a kiteboard's series score will be her total of her race scores excluding her worst score.
- 10.4 When ~~nine~~ ten or more races have been completed, a kiteboard's score will be the total of her race scores excluding her two worst scores.
- 10.5 Eleven races are scheduled.

## 11 [DP] [NP] SUPPORT PERSONNEL AND VESSELS

- 11.1 Support persons shall register online and if their entry is approved, present a form (Appendix 4) containing the kiteboards they are supporting to the onsite check in point at the boat park.
- 11.2 All support personnel shall comply with CORK's Support Team Regulations <http://www.cork.org/wp-content/uploads/2019/08/Support-Team-Regulations-v1.0.pdf>
- 11.3 Support persons are required to monitor the CORK course channel on their VHF radios and be available to assist with safety when requested. The VHF channel will be stated in the SSI's.
- 11.4 Coaches and competitors are expected to attend the ~~coaches~~ meeting each morning. The SSI's may give additional requirements for support persons on the water.

## 12 [DP] LAUNCHING

- 12.1 Kiteboards shall launch from and return to Elevator Bay Pier.

## 13 DISCLAIMER OF LIABILITY AND RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a kiteboard's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, ~~their crew~~ and their kiteboard to such inherent risk whilst taking part in the event.
- (b) They are responsible for the safety of themselves, ~~their crew~~, their kiteboard and their other property whether afloat or ashore.
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission.
- (d) Their kiteboard is in good order, equipped to sail in the event and they are fit to participate.
- (e) The provision of a race management team, patrol vessels and other officials and volunteers by the event organizers does not relieve them of their own responsibilities.
- (f) The provision of patrol vessels cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

#### **14 INSURANCE**

- 14.1 Each participating kiteboard shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a kiteboard has valid third-party liability insurance.

#### **15 PRIZES**

- 15.1 CORK will provide a variety of prizes depending on the number of competitors in the fleet. Some class associations may provide their own additional prizes.
- 15.2 Other awards may be given.

#### **16 [DP] CONCUSSION AWARENESS**

- 16.2 Competitors and Support Persons under the age of 26, need to:
